- A. REGISTRATION OF RIDERS AND AGREEMENT PURPOSE – in consideration of the payment of a fee and the signing of this agreement, I, the following listed individual, and the parent or legal guardians thereof if a minor, do hereby agree to hire from This Stable a horse, tack and equipment, personnel and trail for the purpose of horseback riding today and all future dates should you return again.

_____ B. AGREEMENT SCOPE AND TERRITORY AND DEFINITIONS: This agreement shall be legally binding upon me the registered rider, and the parents or legal guardians thereof if a minor, my heirs, estate, assigns, including all minor children, and personal representatives; and it shall be interpreted according to the laws of the state and county of this stable's physical location. Any dispute by the rider shall be litigated in and venue shall be the county in which the stable is physically located. If any clause, phrase or word is in conflict with state law, then that single part is null and void. The term "horse" herein shall refer to all equine species. **The term "horseback riding" herein shall refer to riding or otherwise handling of horses, ponies, mules or donkeys, whether from the ground or mounted.** The term "rider" shall herein refer to a person who rides a horse mounted or otherwise handles or comes near a horse from the ground. The terms "I" "me" "my" shall herein refer to the above registered rider and the parents or legal guardians thereof if a minor. This Release is in effect for all persons entering the barn area, riding or not.

_____ C. ACTIVITY RISK CLASSIFICATION: I understand that Horseback riding is classified as a rugged adventure recreational sport activity, and that there are numerous obvious and non-obvious inherent risks always present in such activity despite all safety precautions. According to NEISS (National Electronic Injury Surveillance Systems of US Consumer Products) horse activities rank 64th among the activities of people relative to injuries that result in a stay at US hospitals. Related injuries can be severe requiring more hospital days and resulting in more lasting residual effects than injuries in other activities. I/we further understand that applicant may be participating in a "wilderness experience" and the meaning of this term is defined as follows: the pursuit of adventure type activity in a wild, rugged, and uncultivated area or region, as of forest and/or hills and/or mountains and/or plains and/or wetlands, which would likely be uninhabited by people and inhabited by wild animals of many types and species to include, but not limited to mammals, reptiles, and insects, which are not tame, may be savage and unpredictable in nature, and wandering at their will.

_____ D. I understand that this stable chooses its horses for their calm disposition and sound basic training as is required for riding horses for beginner and novice riders. This stable follows a ridged risk reduction program, yet no horse is completely safe. A horse can be 15 times larger, 3 times faster and 20-40 times more powerful than a human Should a rider fall from a horse it will generally be at a distance from 3.5 feet to 5.5 feet and the impact may result in an injury to the rider. Horseback riding is the only sport where one much smaller, weaker predator animal (the human) tries to impose its will on a larger, stronger prey animal with a mind of its own (horse) and each has a limited understanding of the other. If a horse is frightened or provoked it may divert from its training and act according to its natural survival instinct which may include, but are not limited to: stopping short and abrupt, altering direction quickly at a walk or speed at will, shifting his weight, bucking, rearing, kicking, biting or fleeing from danger. WE RESERVE THE RIGHT TO END ANY RIDING SESSION IF WE FEEL YOU ARE NOT ACTING IN A SAFE MANNER. THE FEE FOR THE RIDE, WILL STILL BE COLLECTED.

_____ E. RIDER RESPONSIBLITY I understand that taking upon mounting the horse and taking up the reins the rider is in primary control of the horse. The rider's safety largely depends upon his/her ability to carry out our simple instructions and his/ her and ability to remain balanced aboard the moving animal. I agree that the rider shall be responsible for her/ her own safety and that of an unborn child should the rider be pregnant. This stable advises pregnant women not to ride horses at any term of pregnancy without the permission, advice and consent of your physician.

_____ F. CONDITIONS OF NATURE: I understand this stable is not responsible for total or partial acts, occurrences, or elements of nature that can scare a horse, cause it to fall, or react in some other unsafe way. Some examples are: thunder, lightning, rain, wind, water, wild and domestic animals, insects, reptiles, which may walk, run, or fly near, or bite or sting a horse or person; and irregular footing on out-of-door groomed or wild land which is subject to constant change in condition according to weather, temperature, and natural and man-made changes in landscape.

_____ G. CARRY-ON OBJECTS AND SHARP NOISES: I understand that riders must not carry loose items on rides which may fall, blow away, flap in the wind, bounce, or make sharp noises, possibly scaring a horse. Some examples are: cameras, hats not securely fastened under chin, toys, purses. Riders must not make sharp loud noises such as screaming or yelling, which may scare a horse.

_____ H. SADDLE-GIRTHS NATURAL LOOSENING: I understand that saddle girths (saddle fasteners around horse's belly) may loosen during a ride. If a rider notices this he/she must alert the nearest wrangler or instructor as quickly as possible so action can be taken to avoid slippage the saddle and a potential fall from the animal.

_____ I. ACCIDENT / MEDICAL INSURANCE: I agree that should emergency medical treatment be required, I and/or my own accident / medical insurance company shall pay for all such incurred expenses.

_____ J. PROTECTIVE HEADGEAR OFFERING: I, for myself and on behalf of my child and/or legal ward have been offered a SEI certified ASTM Standard F 1163 Equestrian helmet by this stable and do understand that the wearing of such headgear while mounted, riding, dismounting and otherwise being around horses, may prevent or reduce severity of some of the wearer's potential head injuries and possibly prevent the wearer's death as the result of a fall and/or other occurrences. It is understood that stable-provided protective headgear may not be of perfect fit for each rider's head, and that once provided I/we will be responsible for securing the helmet on this rider's head at all times. **All participants in horse activities MUST wear a SEI certified helmet in order to participate. SHOULD YOU BE OVER 21 AND REFUSE TO WEAR A HELMET, YOU WILL NOTIFY THE INSTRUCTOR IMMEDIATELY THAT YOU HAVE NOT INITIALED THIS LINE ITEM**

_____ K. LIABILITY RELEASE: I agree that in consideration of this stable allowing my participation in this activity, under the terms set forth herein, I, the rider, for myself and on behalf of my child and/or legal ward, heirs, administrators, personal representatives or assigns, do agree to hold harmless, release, and discharge this stable, its owners, agents, employees, officers, directors, representative, assigns, members, owners of premises and trails, affiliated organizations, insurers, and others acting on its behalf (hereinafter, collectively referred to as "Associates"), from all claims, demands, causes of action and legal liability, whether the same be known or unknown, anticipated, due to this stable's gross and willful negligence, I shall bring no claims, demands, actions and causes of action, and/or litigation against this stable and its associates as stated above in this clause, for any economic and non-economic losses due to bodily injury, death, property damage, sustained by me and/or my minor child and/or legal ward in relation to the premises and operations of this stable, to include while riding, handling, or otherwise being near horses owned by or in the care, custody and control of this stable, whether on or off the premises of this stable. **All riders, visitors and parents or legal guardians must sign below after reading this entire document.**
